Ordinance	03-2021	Amendment to Provide for Appointment and Responsibilities of Town Manager	Updates Section 2-2001 to provide for the process of appointing a Town Manager and the responsibilities therein.
Ordinance	04-2021	Amendment to Policy and Procedure Regulations	Amends Section 3-4002(d) to provide for annual and periodic updates to fees and charges for The Lodge and Community Building.
Ordinance	05-2021	Amendment to Water Rate Schedule	Amends Section 51.05, 51.06 to provide for annual updates to the Town's water schedule and revises billing policies and procedures.
Ordinance	06-2021	Amendment to Sewer Rate Schedule	Amends Section 52.039 to provide for annual updates to the Town's sewer schedule and revises billing policies and procedures.
Ordinance	07-2021	Amendment to Penalties for Utility Tampering	Amends Section 52.999 to provide for appropriate penalties and updated legal citations for violations of code section fifty-two.
Ordinance	08-2021	Amendment to Issuance of Tag	Amends Section 70.015 to provide for an annual tag registration fee prescribed by the Board.
Ordinance	09-2021	Amendment to Penalties for Traffic Violations	Amends Section 71.99 to provide for appropriate penalties and updated legal citations for violations of code section seventy-one.
Ordinance	10-2021	Amendment to Speed Limit Schedule	Updates Schedule I (2)(a) to provide for updated streets.
Ordinance	11-2021	Amendment to Penalties for Animal Control Ordinance Violations	Updates Section 90.99 to provide for appropriate penalties and updated legal citations for violation of code section ninety.
Ordinance	12-2021	Amendment to Repeal Business and Privilege Fees	Repeals Section 110.01 which required a business/privilege fee, which is no longer allowed under current law.
Ordinance	13-2021	Amendment to Adopt Revised Trailer and Mobile Park Regulations	Amends Chapter 115 to provide for an updated trailer and mobile home ordinance.
Ordinance	14-2021	Amendment to Code Enforcement	Amends Chapter 151 to provide for updates, revised definitions, and legal proceeds to abate code enforcement violations for residential and nonresidential properties.
Ordinance	15-2021	Adoption of a Tower Ordinance	Provides for a tower regulation ordinance.
Ordinance	16-2021	Amendment to Consolidate and Redefine the Planning Board and Board of Adjustments	Amends Title 15 to merge the Planning Board with the Board of Adjustments and defines the role of the revised board.
Ordinance	17-2021	Amendment Regarding Loitering and Assembling on Streets and Sidewalks	Updates Section 130 to provide for updated legal guidelines for public assemblies.
